To offset the bank conspiracy / Attorney General's release scam to counter an insurance scam to abandon, litigate and liquidate. This is fraud as identified by the crown.
- The video tape '**America Burns**' backs up the Asian approach to the university degree of simulation. To mean of course to study all the experts and with their combined expertise to always move forward. For example the Police administration moving from crime control / correction to Risk Management created a '**win-lose**' scenario instead of a '**win-win**' scenario, as used by the fire brigade who now specialise in rescue management and fire prevention. **As with criminology to 'crystallise the loss' and to work backwards to identify the method of the fraud.** Fraud being identified by Detective Sergeant Brett Heath, ACCC, APRA, ASIC, CMC, LSC, in a nutshell as a Commonwealth Bank circus where the Relationship Manager was sacked and transferred to Westpac. The Police Minister Tony McGrady and the Attorney General Rod Welford were transferred. Rod Welford confessed he was cheated and deceived by the ex-DPP Barrister Davida Ellen Williams. Hence Police Operations Branch confessed false charges of stealing an abandoned 300mm excavator bucket (**The Head Contractor never paid for 14 months hire of the truck and excavator, see Arbitration scam.**) to create the illusion that we were linked with criminals. To create a criminal file to throw you off

- the track. The Attorney General's release scam **not to sue the Police for wrongful arrest** was used in part to hide **the CIB scam**. This was offset by our Solicitor Reg Klinedon's confessing **a) we must prove bank liability, gain confessions of guilt and prove ourselves to be accountable. b) After he was directed to gain a full bank confession of guilt and accept the \$25,000 to prove liability he said "I will swear in court I did the best I could."**
- Grahame Ledwidge's scapegoat Risk Management policy was based on the principle reference Barrister Walter Sofronoff. "**Both sides will not be happy with the result.**" The understanding that Grahame Ledwidge after making his first mistake of directing us "**To rip up (the buyers) contracts,**" meant due to the law of probability more would follow. He has made further mistakes. He did not accept the fact that in paying one defendant \$25,000, he must pay them all, the mums and dads and first home buyers. **They have all lost money and have not been compensated for their legal and binding contracts, which they still hold today.** Hence mediation expert Chris Watts' direction, which we have followed by law, quote "**To defend our mothers at all cost.**" Backed up by the Sisters of Mercy Risk Management programme and information overload as acknowledged by the prisoner/Barrister who has battled to conceal the truth as an expert by law. \$25,000 was paid by Grahame Ledwidge and Relationship Manager James Pitman was sacked, leading to the bank '**Deed of Compromise**' which we have proved is an illegal act as it has been used to cover up an illegal act.
 - Now the importance to study as senior Police advise "**The bad old days.**" The success of the book '**The Bagman**' to explain how Jack Herbert disbursed the funds from Police Commissioner Terry Lewis down and the importance to understand that **fraud in the building and construction industry is a real crime.** As evidenced by our case and the direction of the Brisbane City Council Internal Investigation Department file. Hence the need to investigate

proven inaction of the Fraud Squad. The Chief of Staff of Police, Police Commissioner, Lord Mayor, and Premier must rely on advocates, sponsors, **'whistleblowers'**, and volunteers, as fraud is acknowledged as our biggest billion dollar crime. Here is an ideal case for law reform backing up the mediation expert Chris Watts. Being allowed to work with the Relationship Manager on a verbal agreement over the phone where we would save up to \$12,000 on forward exchange contracts as part of standard bank procedure. In other words the bank Relationship Manager James Pitman was classified as an expert by law to look after our portfolio of accounts. In blaming James Pitman for not correcting our illegal incomplete loan agreement Supreme Court Judge Margaret White directed **"To gain disclosure by law."** You see our problem, the weakness of our legal system and the Police Operations Branch to follow up the technical detail to win this case. Hence Grahame Ledwidge's poor management skills is another attempt, in a nutshell, he confessed **"Bank mediation will be to the bank satisfaction."** To mean, the bank payment of \$25,000 and part confession of guilt was enough to warrant the Attorney General's Rod Welford's planned abandonment of this case. Hence the importance to find the Premier's solution. Rod Welford's directions quote **"The Queensland Police are in charge of this case"** and to have Rod Welford move to another ministerial position. As with the Police Minister Tony McGrady. How can we explain all of this? The need is to study the book **'The Bagman'** to be a witness more than once to CIB detectives working for organised crime. Evidence and proof in Mt Gravatt Police records of senior CIB detectives directing **"To keep your mouth shut or we will be back."** (This is serious crime.) Fortunately other advocates, sponsors, **'whistleblowers'** and volunteers put Police Commissioner Terry Lewis in prison.

Fortunately the book **'Broken Lives'** gives you a lead into an understanding of crime and correction. Police will argue it's not easy to get a conviction. Why is that? The answer is obvious; the most over used statement in any court case is the statement **"It's not relevant."** How is it possible to get to the truth when the Police report quote **"It's the detail that solves the case"**? When evidence is not presented, hence with planned abandonment and endless years of frustration to gain closure.
