
WHY CBA APPROVED 'FIRE SALE' SOLUTION?

1. a/ To lay Police criminal charges to expose this \$4.4m money laundering model. Think of it this way, "**To be or not to be, that is the question?**" (*It must have a solution*) (i) Our motive, (*as a victim of the victim*) my ex-wife and therefore superfund co-director, a breast cancer victim panicked at the thought of death. My heart was no longer in the business, so I sat in my office for 3yrs and just wrote a book, mainly for Aran and Belinda, **knowing it would never sell**. I gave a copy, called '**Does Marriage Have a Use by Date**' to Legwidge, he said "**Breast cancer and divorce is a death sentence.**" (ii) After the CBA illegal incomplete loan agreement helping to cause the '**Site Solutions**' protection racket,
2. a/ Within a few months we were 75% finished and then I was approached by Brad Jones to pay **\$30,000 protection from Rob Wilson**. Our then Solicitor Adam Sambrook, with the aid of Wilson's first three Solicitors explained how the '**Site Solutions**' protection racket works:- (i) Under CBA direction we replaced the Project Engineer Greg Henwood who was approving extras at up to 300% over cost.
