★ **HOW ATO PROVE CRIME EXISTS!** ★

4/ **Association:-** The Justice Minister Rod Welford:- (i) apologised for being tricked, cheated and deceived by his ex-Uni law friend Davida Ellen Williams, a now proven ex-QDPP MOB Barrister. (ii) He gave this case to the then Police Minister Judy Spence. (iii) Then Welford resigned.

5/ **Accession:-** Spence (i) directed I volunteer as a proven prison reform consultant this (\$1million) budget, (ii) to support the Police Admin, Prosecution, Union, Media and Fraud Squad frustration **to lay criminal charges.**

6a/ **Abandonment:-** E.g. the Fraud Squad Det. Sgt. Brett Heath said (i) "If you do not have a copy of the CBA loan agreement (destroyed by Davida) you do not have a case." (ii) **NO!** This is the crime of 'abandoned evidence', a far too common Police Union complaint.***(TBC) (iii) Heath then demonstrated smart / natural justice and said "Get your (RICO) act together (or LSC Barrister Scott McLean) or you will be out the door so fast your bum will not touch the ground."

b/ **Focus:-** We have a minimum of 20 major unsolved scams or crimes to chose from. Davida as a crown Prosecution expert chose to go to prison for her most obvious crime, (i) her 6 bank \$1.3m scams as a cover up. (ii) To protect her major town planning cartel, subdivision, construction industry 'Site Solutions' protection racket, (iii) explained in brief by BCC site inspector Gary Kopp and Baseline Civil Engineers Report for Snr Const. Max Williams, Wynnum Police, who gave me the EPA Sect. 32 copy as 'crown evidence' for me to run this case! (iv) The good news is, to run this scam, we have a 3rd group of victims / the subcontractors, **the backbone of our case.** Det. Ian Tuddenham / Wynnum, explained the electrician with 4 witnesses (refer electrical engineers report) can lay assault charges against the Head Contractor / 'bagman' Rob Wilson. Wilson sabotaged both our subcontractors and subdivision to become an estimated \$4.4m creditor to pay the kickbacks and bribes to confirm this Crown model to prove the need for this International RICO Act.



WHAT DOES BOTH PRISON AND LAW REFORM PROVE?

Success by copying the crime, control and correction model. You will soon learn not all criminals are the same. We have three major groups;

1. The crime of passion:- this group, you are warned by the prison warders to stay away from, as they hate the world and need special help. **If you go near them, you do so at your own risk.**
2. The crime of stupidity:- this group are considered mostly harmless, some are used for sex and referred to as meat, or poor stupid bastards who **do not have the brains to stay out of prison.** They too, as **major suicide style victims** need special help. (*Another major healthcare correctional solution!*)
3. The crime of fraud / racketeering, (e.g. *Davida, the QLS model, best case for law reform*). (i) Sadly this group is protected by the name '**rogue criminals**'. They are not treated by the justice system or the community (*Cabinet*) as real criminals. (ii) *Davida* bragged how she tricked 14 Judges with a legal loophole in the Vexatious Litigants Act. To mean, trick the Justice Minister and you trick all Queensland Judges, proving the need for the Racketeering Influenced Corrupt Organisation Act.
4. *Davida* picked her mark, e.g. (i) there is always a Government employee, prison contractor or prisoner who **will pay for corrupt legal counsel.** (ii) Better understood as a prison inside trading system, where *Davida* operated on the basis of **the greater the crime the greater the kickback and bribe.** (iii) Check *Davida's* '**power of attorney status**' as a condition to act for all prisoner clients. (iv) Prisoner's loss of profit from crime and the loss of their homes. (v) To support the Police request **to set out this case for the CIB to lay criminal charges.** After the Fraud Squad failed as a breast cancer / divorce victim I fell victim to *Davida's* \$20p/h payment plan.
5. It should be noted fraud is not our biggest crime, racketeering is:- To use standover tactics, violence and intimidation. E.g. (i) CIB Det. Insp. Trevor Kidd's hidden intimidation style nun-chucker attack, (*with a QDPP release not to sue Police for wrongful arrest*) (ii) with the hidden extortion demand for \$47,691, (iii) Wilson was desperate as the extra payments at up to 300% stopped, but he was committed to pay kickbacks and bribes to his racketeer partner Brad Jones.
6. One Senior Police Officer asked the question "**What makes you think you can trust me?**" When ex-Premier Beattie and his Court Registrars have asked "**What can I do?**" The solution is obvious, act on the Supreme Court Judge Margaret White's CBA disclosure order. You have to feel sorry for honest Police! The QLS solution is obvious. Do not put all the power of our justice system in the hands of the Justice Minister only. Follow the standard psychology procedure to share the workload with the 14 Judges, **to resolve this legal loophole.** The need to maximise the benefit to the victims, e.g. PM Gillard explained how a forced '**fire sale**' creates a loss, our forced '**fire sale**' created both ATO and superfund victims in common. *Davida's* prosecution scam was to create the illusion this QDPP, ATO, BCC / IID and superfund scam did not exist.
