Clue 1/ Why are both federal and state Police fast to say **"This case is closed"** when it's not?

Clue 2/ You cannot have a major money scam without a major ATO money loss. Therefore, you must Police the ATO **'crime circuit'**. It will tell you what you need to know, thus prevent that tired excuse **"If it sounds too good to be true, chances are it is."**

Clue 3/ That is why the smart ATO investigator and key Supreme Court witness to our unsolved case Tony Coburn and his team also offered help as a **'whistleblower'** to investigate this BCC / IID confirmed subdivision **'Site Solutions' scam form of forced 'fire sale' tax loss**.

HOW TO COLLECT CRIME PROFITS

1. a/ After our HEHS superfund was all but destroyed by the **'Site Solutions'** scam the ATO Perth run the standard test **'to bypass the fault'**. The failure of the Bne ASIC / CBA cartel 240 Queen St. Bne. and replaced them with an independent trained loss adjustor **who would act without bias**. For the present, we must rely on ASIC Perth who listened to this convoluted / vexatious act and asked the key question **"But who stole your money?"** (I) First you must isolate the CBA approved JF & Pike valuations and the key valuation profit of our 22 block subdivision. Then follow the QLS Supreme Court **'mediation order'** via the Bne, HP and Nambour Magistrate Court Registrars direction to follow the ATO laundered money trail.

Then you will learn the correct procedure to solve this ATO scam. b/ As Qld Police Commissioner Bob Atkinson said in brief **'We must take notice of the QLS (check list on major unsolved crimes) Law Reform Judge Pat Shanahan's opinion'**. His opinion will explain why the CMC and LSC failed the Crown *(the need to check the checkers)*. *** Our court Registrars direction is to work through the Fair Trading Act to return the stolen money to the victims to enable them to pay the ATO their just reward and balance the books by law. To be accountable:- (i) follow the 14 Judges court transcripts.*** (ii) Why did Supreme Court Judge John Muir fail the \$10,000 EPA Sect. 32 test as supplied by the local Wynnum Police in support of the BCC site inspector via the BCC / IID where Judge Muir isolated and acknowledged the scam to liquidate a 22 block subdivision valued at \$4.4m on completion over a \$10,000 EPA Sect. 32 site sabotage test case model to prove this **'Site Solutions'** scam exists. **To prove it's not a joke or an illusion**. Put simply, would you liquidate a 22 block subdivision for \$10,000 without checking the facts? **I think not, but Judge Muir did!** Especially when we were given legal advice by our Solicitor Reg Klinedon quote **"10,000 is throwaway money in (test) cases of this kind"**. He then added **"I will swear in court, I did the best I could."** **No!** When it came to appear in court *(after 18mths of preparation)* his Article Clerk David run the case and we just sat there in shock and disbelief while Davida destroyed our case. Therefore, it's time for Klinedon to have his *(LSC checklist style)* day in court to apologise to all Judges for his planned abandonment of this case. (iii) So please consider our action to run an ATO, CMC, LSC, ASIC and CBA stress test to prove the **'Site Solutions'** scam exists **as a sickness inside our legal system?** Talk to any cardiologist and personal trainer who will explain heart disease is the biggest cause of death and the importance to run a stress test. **Your life could depend on it.** Therefore, the need to look at holistic law and ask why 14 Judges, the Federal and State Police and the CMC / LSC down failed to see this superfund scam. Consider Grahame Ledwidge Credit Manager for the CBA's confession quote **"We never said we do not make mistakes, you should have known."** That is why under the CBA Loans and Relationship Manager James Pitman we devised a CBA Rescue Management plan. To follow the scouting motto to **'be prepared'** but instead of a checkmate solution we were given a stalemate act of fraud. As QLS proof, no solution has been found to this crime, therefore, ask why is that? Is it to escape justice? To confess liability but not be accountable for the ripple effect to the superfund beneficiaries and the ATO who suffer as victims in common. Ledwidge confessed **"I work for the shareholder's profit and the top end of town."** An obvious confession of self-greed and self-gain. Therefore, you must go back and study all 14 Judges transcripts on this case then like Judge Shanahan you will have the solution. (iv) Why did District Court Judge Charles Brabazon dress down our ex-QDPP MOB Barrister? A self confessed forger, fraudster and **now felon**. Best known as Davida, where Davida abandoned all standard legal procedures and did not run the case against the Project Engineer Greg Henwood, also refer Solicitor Klinedon's joint abandonment. Our independent engineering report will prove Henwood was paying extras up to 300% over cost to fund this self funded crime. You will learn this is best understood as **'an ATO Crown case in common'** as we are all victims at a local, state, federal and superfund level. Therefore Judge Brabazon summed up by saying to Davida **"That's not the way to do it."** **But Judge Brabazon also copied Davida's same procedure not to be accountable for Davida's abandonment.** You will find how all 14 Judges acted in series with a domino effect to abandon this case. **No one it seems had the courage to protect the innocent.***** (v) For example, Supreme Court Judge Margaret White failed to gain discovery as to why the CBA paid me \$25,000 for a **'deed of compromise'**. The CBA admitted liability, the first step by law to prove guilt.

Although Davida's vexatious act was to destroy the key Crown evidence, not all evidence was destroyed. For example, Grahame Ledwidge wrote as an answer to Judge White **“The bank does not give disclosure to bank business.”** We will argue for all victims that this is proof that the CBA are in contempt of court. On the evidence provided by Supreme Court Judge John Byrne who warned **“The penalty for this crime is a five year gaol term.”** Therefore proving how our HEHS superfund has lost \$millions of \$dollars. (vi) Therefore have faith in the law! The law explains:- **'no-one knows the facts of the case better than the primary witness'**. Due to the CBA **'deed of compromise'** we are forced to now claim for our victims in common as they must gain compensation after being directed by the bank to rip up their contracts to buy land on average at a **'fire sale'** price of \$75,000 and therefore be forced to lose their superfund benefit of approx \$125,000 each, plus interest and costs. (vii) In so doing, I act for all victims including the ATO claim for their just reward. c/ So consider why the CBA paid \$25,000 to admit liability to one victim only, then sack and blame their Loans / Relationship Manager James Pitman. Therefore, Ledwidge said **“We never said you were a fool.”** As proof, that is why we ran this CBA Rescue Management plan. (I) But I cracked under the standover tactics of our Head Contractor Rob Wilson who was aware with breast cancer and a family history of multiple deaths that my then wife Janice would suffer the same outcome. This caused a ripple effect and I became the victim of the victim and our marriage ended in conflict with a bad divorce. I had been given legal advice that the ATO will confirm, that in setting up a self managed superfund, **the ATO have not automatically come up with a procedure to encompass divorce.** Therefore, acting on legal advice at the time of divorce, we signed all necessary documents, where Janice relinquished claim to her share of the superfund. Her condition was that she received all available cash and I would meet the cost to protect my son and daughter and the superfund beneficiaries. These beneficiaries were encompassed in the CBA Rescue Management plan agreed to by James Pitman, but as Judge Shanahan confirmed Ledwidge compounded the banks mistakes by directing that all **'fire sale'** style contracts be ripped up under the threat that if not our bank account apart from a small housing loan would be closed. The result being the decline of Healthequip. (TBC) At the time my mother also became implicated due to mortgaging her home in a scam to steal her home when she too was suffering major cancer complications. (TBC) Wilson seized on the above opportunities, as his normal bullying and intimidation had not gained his demand for \$200,000 or 2 blocks of land for kickbacks and bribes, he arranged for a bikie to run a nun-chucker attack with a false extortion demand for \$47,692.97 that was mistakenly treated by Police Insp. Ray Loader as a CBA approved invoice for payment. What I could not understand was why now Det. Insp. Trevor Kidd ignored the extortion demand and set out to give our team a criminal record. As proof, study the 9 Police Crime Reports. Ask why the key report from the Rev. Michael Veary went missing. Check the Police Union, Prosecution and Police Media solution, most of this information is on our website. (ii) Shanahan explained the need to study the ATO laundered money trail. **The key \$30,000 payment I made to Brad Jones Civil Engineer who ran the 'Site Solutions' protection racket and the false promise to offer protection from Rob Wilson.** \$255,000 was collected as extras with false claims as high as 300% over cost, refer back to Case 422/2000-2 and Magistrate Ian Austin's refusal to look at the multiple experts report. This \$255,000 was used to pay what is called a self funded crime or for the Head Contractor's legal costs to gain false liquidation to become creditors, to sell off the subdivision and pay the kickbacks and bribes.*** (iii) Right from the start I was told of this **'Site Solutions'** scam via the Head Contractor's first three Solicitors,


who were local Solicitors and keen to expose what you may consider is a more common NZ style protection racket to our Solicitor Adam Sambrook from Grants Lawyers. Sambrook passed this **'protection racket'** case to uptown legal counsel Bain Gasteen, now trading as Cooper Grace Ward. Therefore, I have repeatedly tried to explain this **'protection racket'** to anyone that will listen. Therefore, you must take into consideration our background and credibility with our justice system. We worked in part as prison reform consultants via Healthequip (*which I sold and is now all but destroyed*). Our goal was to upgrade our prison system via the crime control correction model to correctional centres. I followed my love of chess as a teenager, to learn to think 5 moves ahead. Therefore, I chose to work in a testing lab where it's standard procedure to test the product, find its faults and weakness, then to write up a report to SAA, TGA, AMA and Crown standards similar to the EPA and IPA procedures. In brief, our procedure was to teach the manufacturer or supplier how to make a better product. We would like to think with R & D, staff training, running regular seminars and sponsoring regular trade delegations including major overseas universities we helped to save up to 100,000 lives across Australia and beyond as part of the united team. A simple example is to replace **Police Risk Management with Police Rescue Management. To become a real force in crime prevention, not just a puppet for organised crime. You need to think for yourself and have others follow your lead.** (iv) As proof, I have volunteered this \$1m budget as directed by the Police Minister Judy Spence, because in part I was told by Magistrate Ian Austin, Case 422/2000-2, quote, **"I do not care what (anyone from) the Police Minister down has to say."** I do care! This is not the first Police Minister I have worked for, therefore, then Justice Minister Rod Welford apologised for being tricked by Davida who was forced to run this scam by the CBA (*refer Ledwidge*). **Davida's option was to go to prison for her \$1.3m scam or destroy our evidence and gain a non prison term. As proof, that this plea-bargain was exposed, Davida was forced to go to prison 2yrs later and to keep her mouth shut.** Welford then apologised and resigned as Justice Minister.*** (v) Assistant Commissioner Pat Doonan therefore apologised in detail and then resigned after he explained his **'abuse of public office'** and **'obstruction of justice'** to the then Premier's solution via the PESC, Attention Assistant Commissioner Peter Martin. In brief, four times our team were charged with fraudulent charges, in an attempt to give us a criminal record, to hide the CBA scam. This led to the discovery of this **'Site Solutions'** scam and the ATO non-payment being exposed by ASIC Perth. This exposed the ASIC / CBA / Bne. cover-up. One of several Police Assistant Commissioner's on this case explained **"Most crimes are exposed by mistakes"**. (vi) So consider, what does the Integrated Planning Act mean? To work together as a team for local, state and federal Government to work with self managed superfunds, to listen to all fraud victims and **'whistleblowers'**, to gain a universal RICO style checkmate, **not a stalemate form of protection racket.** As a fellow ex-public servant and BCC employee you would have to agree you live in a box, you just follow orders and are told more of **what you cannot do than what you can do.** Given the chance to test and assimilate, you can build a better law product and provide quality of life. Hence, **the 'can-do' concept.***** (vii) I put it to you, given Tony Coburn and his tax evasion team to explain how this **'Site Solutions'** scam works, then check the facts, the overall model to sabotage a product, construction site or business, **to buy at a 'fire sale' price or as creditors is the most common misunderstood scam or racket affecting both big, small business and our superfunds.*****

2. a/ In running up to 5 small business at one time, I found sabotage, theft of money and stock the cause as to why in the early 60's the ATO reported that 80% of small business failed to last 8yrs. I would like to list out 20 major scams, for example, a friend of mine recently purchased a second hand Mercedes for

\$35,000 only to report that a repossession agent collected the car, informing him that the seller had returned to NZ and it would seem no Police formal charges would be laid as the general quote **“This is a civil matter outside the control of the Queensland Police.”** In our case, as a previous hire company, one of our major losses was caused when New Zealanders would hire expensive body building equipment; sell it off at a fraction of the cost to fly home to NZ for the same NZ form of protection from criminal charges. b/ Suffering with obvious depression, I sought help from Dr. Frank Walsh Clinical psychologist. As Frank would say, **“Stay focussed.”** I am told by other victims and various legal counsel; Davida, having worked for the Crown Prosecution was in the habit of working in the prison system to gain fraudulent employment. Her procedure was to agree to act as legal counsel for prisoners, on the strict condition, to gain power of attorney, so that any assets owned by the prisoner, normally their home, could be sold off as so called legal costs. My point being, Davida was very much aware that she was offered protection through our justice system and on no account would the community at large believe the victim's claim against the DPP or the Police Risk Management Dept. b/ Therefore, the death threats to keep our mouth shut, only to be told by local Police, quote, **“We get death threats all the time, but we ignore them.”** Therefore, we rely heavily on Judge Pat Shanahan's opinion and the high standing of the QLS promoting the ideal concept, 'first defend the law', quote, **“This is the best case (currently under his investigation) for law reform.”** c/ We were forced to sell our 22 block subdivision at a 'fire sale' price. This meant we gave away both the superfund profits and the ATO just reward. (We sold under cost.) Fortunately our Prime Minister Julia Gillard gave a similar news report to explain how 'fire sales' cause the loss to be passed onto the Crown. This is best understood as victims in common. d/ As part of a normal tax investigation, I put it to you, **'Your proof of abandonment is fraud.'** In honour of Army Colonel / Judge Pat Shanahan, the best of the best, his crime prevention style of education and training is the solution. I worked under his guidance as a team player, he summed up by saying **“Your story is so unbelievable it's believable.”** e/ As the Fraud Squad put it, best known in the crime industry as natural or holistic justice, to mean, just fill in the gaps, quote, **“Get your (RICO) act together or you will be out the door so fast your bum will not touch the ground.”** As the son of a WO1 in the RAAF, the equivalent of an Army Sgt. Major or a Navy Petty Officer, as a 7yr old my father lifted me off the ground with his boot, as I did not move fast enough to pass him a garden rake. It only happened once, after that I thought 5 moves ahead. The problem with this case, it has taken 10yrs for you to start to listen, so please listen to our new Lord Mayor Graham Quirk. Like the ATO, with our help he has primary access to BCC racketeering. As proven innocent at least 4 times our record is sound, do not protect the proven guilty. A criminal after all is a criminal; no matter who they are they must pay for their crimes. No crime has ever been solved by your abandonment; you can solve what you may see as unbelievable. This is only a brief, we can bury you with proof, but as a condition all Judges must first listen to this proof, then they can act. I put it to you, how is that possible with a corrupt MOB Barrister, now felon who acted as our legal counsel? How is it possible to gain justice? My resolve is to never give up. I also have a dream of a world free from well organised crime.

REPLY TO SUPREME COURT WARNING TO SUPERFUND INVESTMENT SCAM

Dear Lord Mayor Graham Quirk;

Many thanks your letter dated 01-06-2012.

To keep you up to date with our progress, as part of our duties as a prison reform consultant's team, we have clearly suffered with character assassination, with which I am sure you are familiar. It's important therefore to re-establish our credibility. As a child, I learnt the basic principles of life. I was told in bible studies "**Just keep the faith.**" So I put it to you, after my father's death, my mother in trying to help me through divorce, mortgaged her home, only to be confronted with a scam, in brief, to steal her home, but in today's society everyone is pre-occupied and seems very reluctant to get involved.

So I beg you, to trust your BCC inspection staff and site inspectors and wherever possible anyone that volunteers their money, time and that offers to act as a '**whistleblower**'. My motive:- I was attacked in my own home at 110 Dairyswamp Rd, Belmont, by two thugs armed with both a nun-chucker and fraudulent demand to pay \$47,692.97. Put simply, I was delivered a wake-up call and my life will never be the same. Having a set of kitchen knives in front of me, I grabbed a large knife and took on my attacker. To my shock, he just stood there, in a few seconds my knife was at his throat and his eyes bulged with shock. After the screaming and yelling, we both calmed down, I did the obvious and contacted the Police. He fled in a motor car spinning his wheels as he sped away. I filed ongoing Police reports, but what happened next was explained by Army Colonel/Judge Pat Shanahan as a story so unbelievable it's believable. The local Police administration found it too hard to set out the criminal charges, **due in part to the principals who were running this subdivision protection racket.** Based on a legal opinion from our Barrister Paul McQuade, we were directed to gain a Supreme Court '**mediation order**', thus gaining court Registrars support. I see education and training similar to the ASIC, ACCC, Fair Trading Act via the Integrated Planning Act to support the '**Little Black Book of Scams**'. Crime prevention is the solution, we must therefore focus on (i) the Ponzi scam, (ii) the sub-prime mortgage loan scam, (iii) the '**Site Solutions**' scam. This is of national importance, so I beg you to do all within your power to help introduce this town planning SAA style law reform and to support the introduction of the International Racketeering Influenced Corrupt Organisation Act. As a volunteer, I will meet anyone of your choosing to improve our quality of life.
