b/ The need for change, to think smart, to defend our rights against all odds. Therefore, having worked in healthcare, crime prevention and prison reform we were engaged by the Queensland Police Admin to set out this case so charges could be laid by CIB Det. Mark Hughes.
5. a/ Focus on the facts:- the ATO alleged loss for our HEHS superfund tax return was \$460,311. Our tax return has been completed by '**Explorer Super**' and we have paid \$16,426.10 with volunteered penalties for late lodgement. The delay was caused to prove *Abandonment, Litigation, Liquidation (ALL-fraud)* = an ATO alleged loss of \$443,884.90. Coburn's request to check or reform this ATO, ASIC, CMC, LSC, EPA sabotage FOI model was denied. Hence, the now improved Vexatious Litigants Act to the Vexatious Litigants Procedure Act. Focus on the facts, not how far up the social ladder the proven criminals are. E.g. Who would have believed that our own Barrister was an ex-QDPP criminal and now prisoner, who hid behind a 6 bank \$1.3m scam where the NAB were furious at the CIB and CBA cover-up actions to sue the victims for forgery.
b/ Therefore, we were warned **"If this was Melbourne, you would be blown away in the street, but as this is Queensland, the CIB can take care of it."**
c/ Learn the SAD story of Stupidity, Abandonment and Denial on behalf of the Police Risk Management section to prove:- (i) Area Commander Steve Pettinger's 4yr delay, quote **"This is a civil matter outside the control of the Queensland Police."** Confirmed by ASIC Investigator Helen Armfield Bne. To mean, an ATO, NAB, CBA, reform matter the CMC ignored as well as:- (ii) Insp. Ray Loader, Doonan's Staff Officer quote **"If you had paid the \$200,00- or given 2 blocks of land to the Head Contractor ('bagman') Rob Wilson he would have stopped trying to beat you up! Better you had paid. *** The chance of meeting Doonan will not happen."**



Thanks to the ongoing intervention by this Community Cabinet model, both the then Justice Minister Rod Welford and Doonan apologised and resigned, for Doonan tricking the then Chief of Staff Superintendent Peter Martin via C.C. Sect 200 & 205. b/ **Hence the involvement of the Court Registrars fed up with cases that last 10yrs and are obviously not resolved.** Honest Police need this Crown evidence and consultants that understand self help is the best solution. c/ As the CBA Senior Credit Manager Chris Watts put it to me **"You have a big thing about teamwork."** **This QLS case proves it! You need to listen to all the facts to gain the Premiers solution.*****
8. a/ As Clinical psychologist Dr. Frank Walsh put it **"As the son of a WO1 in the RAAF you just follow orders!"**
b/ I also made a promise to my Mother **"One day I will pay you back for all your hard work."** I plan to give mum in the area of the \$125,000 that was stolen as part of our superfund, along with others known as the CBA \$850,000 group. Instead this crime cartel via her home mortgage for \$110,000 threatened to steal her home. As proof, if she did not pay the extortion demand for \$47,692, that came with the CIB ignored nun-chucker attack. 9. As Dr. Frank Walsh put it, **"It's only over when it's over and it's not over yet."** The ATO, instead of going after the crime cartel for the alleged \$443,884.90 have now requested an extra \$18,736 payment for late lodgement. Explorer Super explained we can contest this figure. **Yes we will!***** Hence this ongoing Crown evidence must reach the 14 Judges to rule on this case.
10. a/ Therefore, our plan is to expose the **'Site Solutions'** protection racket **with the initial payment of \$30,000 as proof.** You can see why our Premier Newman promised a press release and now relies on his Community Cabinet via Ministers Fiona Simpson and Andrew Powell to expose the EPA Sect. 32 sabotage to building projects by removing the protection barriers to flood the drains, roads and footpaths to prevent completion and gain liquidation via perjury, to become creditors to pay the kickbacks and bribes to the crime cartel. **See all the photographic proof** where protection barriers were removed prior to a heavy thunderstorm that destroyed our worksite.
