

WHY Leadership Intelligence Faith Endurance COUNSELLING?

1. Please refer Dr Michele Pathe Senior Forensic Psychiatrist, Ph: (07) 31397200 for a Community Cabinet solution / Supreme Court order as a QDPP release condition to drop all fraudulent criminal charges against our Manager Gary Armstrong and myself from NAB forgery for \$198,000, theft, child assault and molestation by Police Risk Management to cover up their mistake, to create the illusion that we could not be trusted as a superfund director, to expose this HEHS superfund scam. We were requested by the then Police Minister Judy Spence to set aside this \$1million budget in support of the QLS, Labor, LNP and Independent's solution.
2. Due to the Mental Health Act, I was placed behind steel bars for 16 days to be tested and told if I refuse to take medication I would be held down and given a needle and finish up like a vegetable. Thanks to Michele's opinion that I am of sound mind, I have not been forced to take more medication, what a relief. We have been forced to agree we will give up our legal rights and quest as joint victims in common, to expose Criminal Code Sect. 200, 205, 391 and 399. This is in support of the LBB on Scams and in particular page 16, where my mother explained to Michele how our Head Contractor Rob Wilson in failing to gain our superfund profit via the '**Site Solutions**' protection racket, tried to steal my mother's home. Wilson's scam was to use a false invoice as part of a home loan mortgage scam. Michele has explained, that this is life; in brief, we will not get justice.***
3. All superfund beneficiaries have therefore lost an expected \$125,000 benefit. I explained to Michele it all comes down to CBA humanity, love and kindness. As proof, the CBA paid \$25,000 to admit liability to the original loan mistake that helped create this chain of criminal events.
4. We came so close to our final goal, but to spend 16 days in a mental institution with a threat of more to come, and to be converted into a vegetable, is more that we can stand. So we leave the challenge to you to try and convince Michele, (*a Professor in Criminology*), to mediate with the ACCC, ASIC, CALDB and CBA group. As the Fraud Squad put it, "**To get your (RICO) act together**" and to build on the LBB of Scams, to educate the community to prevent the theft of all superfunds primarily associated with the subdivision / building industry style racketeering and corruption.
5. As a QLS identified unsolved case, before we fade away into obscurity we have been offered counselling by Michele, where I have failed as a superfund director to meet my obligations. We ask you to consider what is life all about? Previously QC Walter Sofronoff explained "**Mediation means to meet somewhere in the middle.**"
So please consider:-
 - a/ **Leadership**:- I grew up with my Mother telling me "**We cannot afford it.**" My Father telling me "**Learn from other peoples mistakes.**" The result; I came up with a family plan, never to tell my children Aran and Belinda "**You cannot afford it.**" The principle, **to work as a strong family unit, but I failed.**
 - b/ **Intelligence**:- I paid to go to self management courses and I followed the USA principle to have not one, but up to 5 small business at the one time. Healthequip was our flagship, **as seen on TV**. Our family / business plan was to prevent the home mortgage trap.
 - c/ **Faith**:- From 8-12yrs of age I went to Church and in brief, I was told to stay back for bible studies, but by 12 I was told the burning bushes, turning people into pillars of salt and the parting of the waters may seem strange, but the important thing was to keep the faith. **So I moved forward.**
 - d/ **Endurance**:- The Boy Scout principle '**To Be Prepared**'. When it turned out our Barrister was a confessed NAB forger, fraudster and now felon I was given legal advice by the QDPP and others "**Never give up, just keep telling the truth.**"

The Mental Health Act via the Acute Care Team incorrectly diagnosed my action as obsessive and compulsive and I was seen as a risk to our previous Local Member of Parliament, now Minister, Mark McArdle. When in fact the previous Police Commissioner Bob Atkinson advised as standard Police procedure, we keep the local Police up to date **with all new evidence**. The local Police at Kawana advised me to contact Mark McArdle, as apparently they believed he was in charge of our case as our previous local member at Caloundra.

6. Fortunately the ACT group has agreed to Michele, as a forensic expert, to take over our case.

a/ We believe in our justice system, but due to our MOB Barrister, **the 14 Judges on this case never had the opportunity to listen to the evidence**. Therefore you must support the expansion of the Little Black Book on Scams, the Legal Services Commission reform and the implementation of the RICO Act.

My Mother explained to Michele, as Armstrong and others can confirm, that Rob Wilson did try to steal her home and mum believed that if she did not pay a proven vexatious invoice, then according to her mortgage conditions, she would lose her home and be forced to live in a caravan park. Mum has also praised my new partner Lyn Nichols, whose family are part of the Queensland Police Force. Lyn agrees that it is wrong to be forced to take medication to resolve what I was previously told 10yrs ago by Dr. Frank Walsh psychologist, in brief, **'I cannot solve your legal problems, I can only state I believe you are of sound mind.'** **To mean, no drug can smash racketeering and corruption.** We believe, if you learn to listen to our original 3 Barristers; Barlow, Sweeney and McQuade's opinion, **we will succeed**. Supreme Court mediation and CBA disclosure orders have been fraudulently ignored; commonly referred to as **contempt of court**. (*We have the proof.*) This evidence will confirm former Premier Peter Beattie's requested solution and Premier Newman's promised follow-up Courier Mail press release for law reform. Obviously our lives are in chaos, due to circumstances beyond our control.

We therefore look forward to Michele being accountable to enforce law reform.
