

7. a/ In order to break the CBA deadlock, Tim Allen our primary CBA mediation witness and our Accountant agreed to accept \$10,000 from me on the condition he ripped up his contract and lost in the area of \$125,000 on the completion of the subdivision and supplied what Allen wrote and called a '**damages report**'. That is when all hell broke loose and we were confronted with death threats. The best threat was outside the CBA 240 Queen St. Bne. Thanks to a reliable witness the threat was "**If this was Melbourne you would be blown away in the street but as this is Queensland the CIB can take care of it.**" b/ Yes, we have a QDPP release:- to drop all fraudulent criminal charges on the condition, we cannot sue Police for false arrest. This was arranged by Davida as another of her legal scams. c/ In brief, former Police Commissioner Bob Atkinson had Assistant Commissioner Pat Doonan give an official apology for what is called '**the Police Risk Management Dept**', who tried 3 times to give me a criminal record. The motive, to arrange my character assassination, but this is only the tip of the iceberg.
 8. a/ It is not an easy task to put an honest person in prison, as CIB Det. Insp. Trevor Kidd, transferred to Mt Isa will confirm. Especially as I am a prison reform consultant who worked in R & D where it is normal to test and write a '**crime control correction**' report. In support of the then Police Minister Spence's request for a volunteered \$million Community Cabinet solution. b/ We have been given assistance from several Police Assistant Commissioners. One officer checked and confirmed Inspector Ray Loader's involvement and requested the use of the Judicial Review Act.*** On the condition we provided the officer with '**whistleblower**' protection. Therein lies the problem, we can prove our case of multiple charges but the Crown witnesses live in fear. c/ The best example on construction sites where the standard Police procedure to avoid death threats is to state, quote Commander Pettinger's excuse "**This is a civil matter outside the control of the Queensland Police.**" Or now PESC Assistant Commissioner Peter Martin's confirmed fraud by Assistant Commissioner Pat Doonan's direction "**According to Police availability and time this case is closed.**"
 9. a/ So let's focus on the Judicial Review:- Chief Justice Paul de Jersey personally directed Supreme Court Judge Ken Mackenzie to ignore his '**mediation order**'. Therefore he ignored Supreme Court Judge Margaret White's CBA '**disclosure order**'. Therefore he ignored Supreme Court Judge Byrne's penalty for this crime as a 5yr gaol term. He then gagged Judges J Chesterman and JA McPherson and thus protect the CBA from '**contempt of court**' to explain the details in paying \$25,000 to hide the details to the key '**Site Solutions**' protection racket. b/ Therefore the QLS Law Reform Judge Pat Shanahan advised "**You must prove abandonment is fraud.**" Smart Police know this as Criminal Code Sect. 391 & 399, but this is better understood in following the international standard '**Racketeering Influenced Corrupt Organisation Act**'. This act helps the Crown, States, Local Councils, Town Planners, Site Inspectors and superfunds balance their budgets with the return of these hidden profits from crime.
