

WILSON'S SOLICITORS CONFIRMED THIS SCAM!



1. The QLS direction **“To first defend the law”**, meaning:- if Solicitors aid or abet a client as a known self confessed criminal, racketeer or scammer, they could face a minimum 5yr jail term.
2. a/ Our local Solicitor Adam Sambrook was able to explain how the **'Site Solutions'** protection racket works. He then said, quote **“This case is over my head, you need an uptown Lawyer.”**
 b/ Therefore Solicitor Reg Klinedon said in brief, (i) **“I will swear in court I did the best I could.”** (ii) **“\$10,000 is throwaway money in test cases of this kind.”** To mean, a BCC / IID, SAA style test case confirmed by Snr. Const. Max Williams, Wynnum Police in supplying a copy of the EPA Sect. 32 (*sabotage scam*) to prevent completion to our subdivision to gain fraudulent liquidation.
3. a/ This was confirmed by Supreme Court Judge Muir's unanswered question **“Why would you self liquidate a 22 block subdivision for \$10,000?”**
 b/ QLS Judge Pat Shanahan explained our motive. We were given legal advice, even though the CBA paid \$25,000 to admit liability (*to one victim only*)***, **you will not beat the Commonwealth Bank.*****
4. a/ We believe therefore, we must gain the support of the Commonwealth Bank where their primary witness to the official mediation volunteered as a **'whistleblower'**, but informed us that he was transferred to another section of the bank to cover up their mistake to force us to sell land without title and deposit. Therefore, the need to study basic criminology, forensic psychiatry to understand the mind of a chess player, **to plan 5 moves ahead.*****
 b/ Just look at the obvious. We had a subdivision worth \$4.4m on completion. The smart ASIC team Perth listened to our story then asked **“But who stole your money?”**
5. a/ In brief, we lost the profit when it should have gone to the superfund beneficiaries with the obvious flow on effect, where the ATO claimed an estimated loss of more than \$460,000. The end result, **we did not receive one cent profit.**
 b/ So please consider how the scam worked. As the victim to a breast cancer divorce I came home to find both my wife and children had deserted me. As to be expected, I sat and cried for weeks, even though I had been told by Relationships Australia, my marriage was finished. Yes I was the perfect candidate for the **'Site Solutions'** protection racket. Hence the need for the Acute Care Team to listen and I will explain until you realise **'Do not blame the victim, don't treat the symptom, treat the cause.'**
6. a/ Our smart more Senior Project Engineer John Koek explained **what I had failed to see before, the need for Police education and training.** Koek said in brief, **'You must pay the subcontractors to ensure the subdivision is completed, either direct or through myself.'**

We have proof of non-payment by Wilson to the subcontractors. This scam is to gain fraudulent liquidation and steal our superfund.*** Unfortunately neither the subcontractors, the Police or the ATO took the advice of the QLS to follow the money trail.***

b/ Wilson employed another Civil Engineer named Brad Jones who said to me, in brief **'Most subdivisions have an overrun, if you pay me \$30,000 I will offer protection.'***** **So I paid Jones \$30,000 as proof for Police to lay criminal charges and smash this scam.***** Jones promised (i) the violence would stop immediately (*it only got worse*). (ii) The project would finish on time (*instead it was extended from 4 to 16 months*). (iii) You will not need to pay anymore extras (*we paid \$255,000 with extras paid up to 300% over cost*).


c/ The contract stated extras to be paid at cost plus 5%. Therefore the CBA via Grahame Ledwidge took note of the bank's Civil Engineer, JF & Pike's valuation that proved our current Project Engineer Greg Henwood was allowing the site to run out of control and advised we replace Henwood with Baseline Civil Engineers c/o John Koek whose report never reached (i) the Arbitrator, (ii) the Magistrate Courts Holland Park and Brisbane, (iii) the District Court, (iv) the Supreme Court. This crime is known by Police as Criminal Code Sect. 399 or a Legal Services Commission scam.

7. a/ My so called **'obsessive behaviour'** to expose these numerous scams is due to having spent 6yrs in a similar case with the Healthfitequip group passing off as Healthequip, we had to fight the Chemists who were protected by the Pharmacy Board and Guild. The good news, we won as the QLS have confirmed (i) the need to follow the money trail, (ii) the court transcripts, (iii) as the Fraud Squad put it; with proof of perjury in Case 422/2000-2 Holland Park as a starting point.
b/ We can prove the **'Site Solutions'** protection racket at least 20 ways, but first you have to accept the fact that Rob Wilson was an opportunist who had next to no assets and had to run a self funded scam that involved a lot of risks.
c/ It was reported he owned a half share in a grader and previously worked for Col Rosenlund, our Plumber and Drainer. Rosenlund confessed afterwards his mistake in trusting Wilson. Yes the scam is that simple, Doonan's Staff Officer Insp Ray Loader never bothered to check the facts and used the Police excuse; quote **"This is a civil matter outside the control of the Queensland Police."** The sad thing is, neither did the PESCC, LSC, CMC, ATO, ACCC **or the many other people involved check the facts.** This is called the domino effect, one mistake followed by another.
8. a/ That is why I paid my Accountant Tim Allen \$10,000 to write his quote **'damage report'** to support the new Project Engineer John Koek.
b/ The Police Admin, Prosecution, Union and Media worked as one, to advise the need for outside assistance and recommended I first set out this case to have criminal charges laid, but when the Police failed to lay charges I was advised by an Assistant Police Commissioner **'whistleblower'** to act on the Judicial Review Act and also advised to engage the Criminology students via Prof. Paul Wilson who worked out of Police Headquarters to write a detailed report but the students passed off our case as a joke requesting to work on a binge drinking case.
9. a/ Premier Newman as a pre-election promise promised a Courier Mail follow-up press release. He did not know the full detail but was smart enough to identify there was an obvious problem.
b/ The QLS ran a check on our unsolved case and directed to prove **"Abandonment is fraud."**
10. It is now up to what is called natural or holistic justice. As the CIB put it **"The test in patience and time."** Thankfully the Acute Care Team is working on the solution with the support of a specialised Forensic expert in Dr Michelle Pathe. To solve this QLS case of abandonment the

QDPP must lay criminal charges.
