

# WHY 'POLICELINK' 'SCAMWATCH' TO 'CRIME STOPPERS'?


Be part of the solution, do not be part of the problem!

1. You have proof of domestic violence; it's an every day event. What about racketeering, extortion and violence on construction sites? Check how many arrests have been made to one of Australia's biggest scams! As a superfund director and victim to subdivision extortion I was told officially by Police Administration, quote **“Yours is a civil matter outside the control of the Queensland Police.”** The QLS Law Reform Judge Pat Shanahan ruled **“Yours is the best case for law reform.”**
2. In brief, to introduce the International Racketeering Influenced Corrupt Organisation Act as requested by the Fraud Squad. 10yrs ago I was told by the QDPP Prosecution Barrister **“Never give up, keep telling the truth.”** He added, **“We need honest business people like you.”** Therefore former Premier Peter Beattie listened to our story and told me; quote **“Find the solution.”** He then offered his Community Cabinet and I was requested by the then Police Minister Judy Spence to set aside this \$1m Police budget. When Channel 7 TV News got involved, instead of Police coming to our rescue as they have done previously, my Manager Gary Armstrong and myself were repeatedly charged by the **'Police Risk Management Dept.'** four times with fraudulent NAB forgery, theft, child assault and child molestation.
3. The obvious motive, to blacken our names to protect what is commonly known in the building and construction industry as the **'Site Solutions'** protection racket. Being told of the racket by our Solicitor Adam Sambrook, I paid the Civil Engineer Brad Jones \$30,000 for site protection. The QLS confirmed we can prove both **perjury and entrapment in the court transcripts.**
4. When I failed to gain protection and justice three Police called to my home with two nurses, an ambulance driver and paramedic. I was told the Acute Care Team had ruled I was delusional and therefore insane and a danger to society. I was told if I did not take medication, I would be held down and given a needle.
5. So on the QDPP principle to support our new Premier Campbell Newman as a pre-election promise to write a follow-up press release; please note our ex-QDPP Barrister Davida Ellen Williams confessed to be a forger, fraudster and now felon. What was the result of this latest Police supported mental health investigation, after I had passed all previous mental health investigations as standard Police procedure for cases of this kind?
6. a/ Let's follow Premier Newman's direction **“To break the problem up into small pieces and fix each piece at a time.”** As always, first look for a motive. In brief, I explained to Psychiatrist Dr Pamela Hudson-Jessup that as a 19yr old I was on the dance floor and a thug just walked up to me and said **“You're dancing with my girlfriend.”** When I looked at the young girl to ask “Is he your boyfriend” I was king hit and almost knocked unconscious. Six months later I was at the back of a dance hall known as the Railway Institute and four thugs came up to me, one a well known local boxer. They surrounded me and the boxer gave me two jabs to the face. Someone called out fight and I was never so happy in all my life **to see a Police Officer rush to my aid.**  
b/ A friend had told me how he suffered the same experience; in his case there was no **Police presence**, he just woke up in hospital. He reported when he went down the four thugs just kicked him in the ribs.  
c/ It seemed because I like to dance there was always a drunk or thug that wanted to try and beat me up.  
d/ So in my 50's when I was attacked by two thugs armed with a nun-chucker and a now hidden extortion demand for \$47,962.97 I just grabbed a large kitchen knife and fought back. The Acute Care Team therefore ruled I was a threat to society or I was delusional, but I am neither; **all we want is justice.**



7. a/ My point is; I believe in following the CBA Relationship Manager James Pitman's opinion, if I do not give up the Police, ACCC, ASIC, ATO or CBA will come to our rescue.  
 b/ I have spent over \$900,000 in legal costs under Supreme Court ordered mediation and ignored CBA disclosure orders to have you consider the evidence. (i) I was warned, quote **"If this was Melbourne, you would be blown away in the street, but as this is Queensland the CIB will take care of it."** (But not the way you think.) \*\*\* (ii) My case officer Phil Rigby said **"This is a Police state."** The question being; **who does the Police Risk Management Dept. work for?** (iii) Pam said **"Shit happens"** and Phil agreed. That is my point, why do you let it happen? When will you say enough is enough? (iv) The Acting Director of the Mental Health Dept. Dr. Michele Pathè as a Professor in criminology said **"You will not get justice."** (v) Was this because the Previous Police Commissioner Bob Atkinson said, in brief, **'He would not go against Police Assistant Commissioner Pat Doonan who was in charge of Police Risk Management.'** Doonan apologised for breaking Criminal Code Sections 200, 205, 391 & 399 and resigned along with the Justice Minister Rod Welford who requested the Police Minister be put in charge of this case before his resignation. Atkinson told me, as I was not broke, that I should retire on the Sunshine Coast and live on what money I have left. (vi) Our new Police Commissioner Ian Stewart being well informed explained to me, quote **"Most crimes start off with a mistake."**
8. a/ Under Supreme Court mediation the Holland Park and Brisbane Court Registrars directed we study the Fair Trading, CMC and Vexatious Litigants Acts (*now upgraded - refer 2005 amendment as explained by the Nambour Court Registrar*)\*\*\*  
 b/ As a result therefore, we have had to live with the fear of 4 false criminal charges or arrests, of being locked up by the Mental Health Act behind steel bars for 16 days, only time after time to be given an apology for not receiving justice.  
 Best explained as **"SHIT HAPPENS"**.
9. The solution best explained by the Mental Health group is via the Little Black Book of Scams, page 16, with the evidence of an illegal unapproved construction site invoice for \$47,692.97 that tricked Doonan's Staff Officer, Insp. Ray Loader, as confirmed by an Assistant Police Commissioner who as a **'whistleblower'** also checked the facts, but explained he lived in fear of a Police reprisal.
10. Just when you think all is lost and you suffer with depression and abandonment, that no one cares, I remembered what I was taught as a child in Church, quote **"The world may seem a strange place, just remember to keep the faith."** So, Please, as Davida suggested when she confessed to being a MOB Barrister; that I should throw myself on the mercy of the courts. Please follow up on Criminal Code Sect. 391 & 399, because at no time has the 14 Judges on this case ever ruled on the evidence that has been hidden from them. Mark McArdle had the solution written on the wall of his office **NEVER GIVE UP**. Hence the Fraud Squad's direction **"To get your (RICO) act together or you will be out the door so fast your bum will not touch the ground."** No-one should lose their superfund benefit, as the Courier Mail reported **"Extra charges are pending."** Hence the importance of Premier Newman's promised press release.
