6. a/ This is known and confirmed by Assistant Commissioner Police **'whistleblowers'** and several bank valuers to property sites as the Police Risk Management Dept. whose procedure is to ensure the victims character assassination. Then under the control of Doonan who gave a formal apology along with Justice Minister Rod Welford who gave this case to Atkinson and in turn PESC Peter Martin to solve. b/ Davida explained, she was blackmailed by Grahame Ledwidge for the CBA to trick Welford into providing Davida's pardon for her 6 bank \$1.3m scams on the condition she destroyed our key Crown evidence of a CBA loan agreement to sell land without title and deposit. This proven Criminal Code Sect. 391 exposed 399 as a vexatious act of abandonment to cheat all superfund victims and in turn the ATO at their then estimated loss of \$460.311. 

You cannot say Rob Wilson is a liar, etc."** But we can prove Wilson's perjury and the fact that his 4th Solicitor knew the detail in Case 422/2000-2. b/ As Kopp explained for the BCC / IID where Commander Steve Pettinger used the Police Risk Management scam **"This is a civil matter outside the control of the Qld Police."** Would you accept the loss of your superfund and the ATO loss as a civil matter? **NO!** As an honest person you would support the rights to all superfund profits as many do today.
9. a/ There are at least a dozen ways to solve and prevent these rackets and scams, e.g. (i) SAA procedures by BCC site inspectors. (ii) My Dad as a WO1 in the RAAF explained **"Do your duty,"** to mean, **"Keep the faith. Look after your mother after my death,"** but so far I have failed my promise for mum to share our superfund profits with others identified by the hidden CBA loan agreement to Supreme Court Judge Margaret White's request. Known as the \$850,000 group, who agreed to buy land at a **'fire sale'** price. b/ In Mums case, by mortgaging her home, under what we can prove were fraudulent conditions, where Mum believes if she did not pay the \$47,691 scam or the ATO \$460,311, she would lose her home. Before or after her death. Therefore, her original Solicitor Maxwell has abandoned her. (TBC) (iii) The bank run a tort to pay \$25,000 to admit liability to one victim only, leaving the door open under legal advice from the gutless coward our Solicitors Reg Klinedon to expose this CBA tort, commonly referred to as the abuse of a QDPP plea bargain.
