YOUR ABANDONMENT IS FRAUD!

Parliament must act to smash organised crime, to create the Law of Abandonment. To complete Justice John Byrne's 3 step Arbitration procedure by (i) (bikie) association, (ii) (CBA) accession; the principal is as guilty as their actor by blackmail. Known as Davida Ellen Williams, ex-QDPP Barrister, **who was a CBA known criminal**. (iii) Davida is guilty of QDPP / QPS insider trading. Celebrating the life of my Mother; as an only son, I am under Supreme Court ordered mediation from Justice Ken MacKenzie, to answer all Mum's family trust details to our family, friends and workmates. The key questions; **where did our HEHS superfund benefit go and why did the ATO report an estimated tax loss of \$460,311 and refused to assist us in exposing the 'Site Solutions protection racket', when the tax evasion expert team headed by Tony Coburn offered 'whistleblower' assistance?** My adult son, Aran, helped set up this family trust. I will try and explain all 10 key subjects, quote **"That lies in the hearts of men."** This is known in the crime prevention industry as **'natural justice'**. This was explained by the original CIB Det. Snr. Sgt/ Leigh Gowrie, quote **"Time and patience will solve this case."** (14 yrs later)

1. a/ **How to save on your funeral costs to help pay for your legal costs:-** We had 2 options; burial or cremation (to save space and time). Mum requested a simple family send-off. Low key, compared to Dad's RAAF **original** Amberley Squadron send off. The Funeral director offered a smart variation for a half price cost of \$3,500, and we collected Mum's ashes from the Funeral Parlour. We have spent approx \$6,500 on legal costs so far for the Family trust **only**. The plan was to have the wake at our family home, to allow a full day to sit down as an extended family, to correct Mum's injustice. b/ Note, with a family self managed super fund, I made a lot of promises to family, friends and workmates, but first, in respect:-
2. **Mum's send-off:-** Dad led the way, earlier at 75yrs of age with his direction; he wanted his ashes to be spread over the ocean. Being born in England, the hope that one day he would make it home again. Dad added **"If you dump me in Moreton Bay, I will come back and haunt you."** So I chose as far east as I could in Australia, to the lighthouse at Byron Bay. In Dad's case, I went out as far as I could on the rocks and watched him wash away. There is a twist to this story. In Mum's case, being a windy day I decided to stand on the cliff on the lookout and watch Mum's ashes blow away. As I stood there, a group of German tourists came and stood beside me. I waited and waited for them to move away, but they just stood there. They saw I had a container with Mum's ashes. They realised what I was about to do. I emptied the container, and a gust of wind blew the ashes, some over the German standing next to me. I could not help to think how fitting this was with Mum being of German decent, her maiden name being Stabe from Dresden. Without a word being said the German standing beside me gave me a look as if to say its okay you did well. It reminded me of Dad's last words, **"You were a good son."**
3. **Why Mum's financial plan, to protect her home with a family trust?** As a young man I made a promise to my Mother **"One day I will pay you back for all the hard work you have done."** I had no idea at the time that life is full of criminals and investment scammers. As an only son, I was given a special freedom. If I wanted something done, I had to take the first step. This is called self motivation. As a chess player, I learnt to plan 5 moves ahead. The spearhead approach, to break new ground.
4. a/ **Our area of expertise is called simulation as part of R&D.** E.g. I watched an Australian movie last night called **'Men's Group'**. This is similar to the **'Men's Shed'** or **'Beyond Blue'** style men's clubs. Thanks to my Cousin, Mark Bishop's huge success in business, both overseas and in Australia, as a mining and engineering supplier, and as a fellow HEHS superfund victim, he advised me **"To always hold something in reserve."** Mark invited me to join the **'Wombat Club'** for men only. My Aunty Val, Marks' Mother, reminded me of the details. First consider the lesson to be learnt by the **'Men's Group'**. This was a story about how easy it is for men's plans to go wrong and no matter how hard you try, once you become a victim of crime, as Prof. Pathè has confirmed **"You will not get justice."**


The reason for not getting justice is the average person or Police Officer is frightened of mobsters and thugs, and **as soon as you tell them the shocking truth**, most abandon you. We were given 2 options (i) the medical approach, using the excuse (*or scam for the sake of your health*), to just give up and walk away, **to let the criminals keep the profit from our superfund** and to live on anti-depressants. No! As our original sponsor in 1969, Terry White, ex-Pharmacy Guild President and later Minister for Welfare, will confirm our Healthequip TV model. **Do you want more good health, relief from pain and quality of life?** Based on the principle, drugs will not correct bkie extortion and racketeering!*** (ii) My Father's RAAF approach was similar to Dr. Frank Walsh, Clinical Psychologist, and Army Colonel / Judge Pat Shanahan's opinion, **'It's only over when it's over and it's not over yet. You have the ability within you to put things right.'** Yes! Natural Justice will solve this case. Therefore, by law this is seen as a **'men's shed'** style class action. Our need is for the CBA Supreme Court order, based on the principle of victims in common. To unite and stand for all men and this family trust by law, for mediation, discovery and disclosure via 7 Supreme Court Judges, MacKenzie, Muir, Margaret White (*a special case who asked for CBA discovery but never got it*), Byrne, de Jersey (*now Governor of Qld*), Chesterman and McPherson (*who never asked why*). All play a special part of this prison reform / crime control correction model. To find the 4,000 ABC reported CBA victims, spearheaded by the 400 Storm home mortgage investment victims, who have gained some success. We must unite as one if we are to smash organised crime. b/ We believe the CBA are not the criminals, but they did provide a cover for investment scammers and as their victims we have all the answers.

5. a/ **As an extended family with a combined Army, Navy and RAAF background, life was simple and stable.** We made the right decisions based on checks and balances, e.g. we did everything as ordered by the CBA. But we were told by the Credit Manager, Grahame Ledwidge via Judge Shanahan **"You should have known what we meant."** To mean, **the CBA admitted to making mistakes but expected their customers to pay for their mistakes.** This is called CBA self entrapment, or as G.L.'s boss, Chris Watts put it, **"This is a bank circus I do not wish to be part of."** In fixing G.L.'s mistakes, this proves the bank mistakes exist. b/ Most Saturday mornings I listen to the **'Men's Shed'** on ABC Radio. I listen to men like myself who have run into a brick wall, who know what is right and what has to be done to reform the law. After 14yrs, our \$1m Police requested budget cannot last forever. It's obvious we need a bypass. At 3am it hit me, the **'Power of One'** solution, quote **"First with the head, then with the heart."** The **'Men's Shed'** is our best chance to have the **Scamwatch** group get their act together. I have been told by Police that care **"Do not give up. Just keep doing what you are doing."** The **'Men's Shed'** offers hope. As my ex-wife Jan would say to our children **"I do not want to listen to your Father's shit."** c/ Turning 45yrs of age when times were good (*pre-cancer*), I ran 5 small businesses at the same time, with my wife, Janice and 2 children, Aran and Belinda. As I watched the locals play and compete in our Squash and Tennis Centre and 5 pitch Indoor Sport Stadium, to hear them scream and shout filled me with pride. As a close friend, and now fellow HEHS superfund victim, Terry Buckley, a Valuer said **"You're so lucky."** At the time, I thought, yes I am, but how fast things can change. As the CBA's G.L. said **"Breast cancer and divorce is a death sentence."** As a result, he closed our CBA account, but his real motive was to cover up his endless mistakes. The CBA's first mistake was to have me sell land without title and deposit to gain approval for a bank loan. Then to have the CBA pay \$25,000 to admit liability by law. But Justice Margaret White abandoned our case, thereby creating our HEHS superfund victims.
6. **As Dad put it:- "Learn from other people's mistakes."** That has always been my goal, as they put it in the obvious training movie, **'Men's Group'**. There was a system or bond (i) to just sit and listen to each person's reason for attending the group. (ii) On completion, to go around the group and listen to each member's opinion and input. (iii) To realise the obvious, as QC Walter Sofronoff put it **"To meet somewhere in the middle."** To realise not everyone thinks the same, e.g. a 35yr old son thinks differently to a 70yr old Father, but with guidance your son can gain the wisdom of time. Some people refuse to listen and act, as a result, **the above 7 Supreme Court Judges have proved the need for the Law of Abandonment.** (*Remember, this kind of detail solves the crime.*) Therefore, we must never stop trying to make things better. Some people gamble to try and beat the odds. In our case, to use the obvious Criminal Code to fix our incomplete legal system. Some are lovers, where others think a punch in the head will solve the problem. So look at the wisdom of Aunty Val, to understand the terms and conditions to join the **'Wombat Club'**. Their key role, to be **one of a kind**, to keep a balance, to look for variation, to maximise our output, e.g. Doctor / Psychiatrist, Solicitor, Accountant, Video Shop Owner, Engineer, Geologist, Truck Operator, Diplomat or Dr. Orthopaedic Surgeon, Healthcare / Wellbeing / Prison Reform Consultant, etc. This creates limited growth to a group, in our case of 14 members. But as always, there is a downside, hence the need for reform. With 14 shouts at the bar, the normal procedure was to finish up drunk.


Hence, the need for the men's group solution to follow the lead of trained Psychologists, to have a cup of tea in a non-smoking area, except of course on special occasions.

7. a/ **Known by law as the key pivotal point or the body of the case.** There is one thing that eats at my guts. When Jan contracted Breast Cancer and panicked with a family history of death, I had an action plan. **I married for life and Jan knew that.** I soon learnt from Dr. Frank Walsh **"You can only be accountable for your own actions."** As the so-called fat man in the men's group explained, one day his wife said to him, **"Do not touch me,"** and explained why, **"You repulse me."** I have now learnt through life's experiences, chances are his wife had already found a new boyfriend, most likely of average weight. The fat man, being in love, was blind to his wife's faults, as I was. It turned out he was the only one in the group to commit suicide. The rest of the group were devastated and all agreed, if only he had contacted them they would have given support. Yes, prevention is the obvious solution. The fat man tried to explain, as a professional comedian he made jokes about dying, **so one day he did it.** Yes, life is what you make it. Hence, Dad's advice was smart, **"To learn from other peoples mistakes."** Do not kill yourself; just solve the problem of law reform. Listen to the court Registrars advice. We rely too much on the Judges and require more trained experts. The Judges' role should be to sign off and judge the penalty if required. Note: being told of the crime under Police direction, we thereby exposed the CBA incompetence. This is due to lack of education and training. b/ As Prof. Pathè will confirm, there is a need for a CALDB / ASIC LBB of Scams. Similar to the SAA Rules & Regulations to be used as a bank / ATO / business handbook, starting on the top ten scams. My motive for volunteering this QPS requested \$1m budget under the direction of the then Police Minister, Judy Spence, was exposed by Magistrate, Ian Austin's infamous court transcript, Case 422/2000-2 HP, due to Davida's cunning to arrange three years of delays **"I do not care what (anyone from) the Police Minister down has to say."** (*I am sure Magistrate Austin did care, but how could he explain Davida's insider trading?*)
8. a/ As a result of Mum's wake, better understood as family mediation, Mark's wife Ros, reminded me after Jan, my ex-wife (*now divorced for the second time*) contracted breast cancer at 42yrs of age in 1992, she shared a room in hospital with another lady cancer patient, **I just learnt who had committed suicide.** Ros reminded me, as a witness, Jan, met the ladies husband in 1992. Jan went behind my back and became his girlfriend from 1992 to 1996, when we divorced. **This was 4yrs of hell.** Therefore, Mark, knowing the obvious, invited me to join the **'Wombat Club'**, which was the start of 10yrs of my depression recovery. b/ To explain Jan's solution, as she did not have the courage to confess in full, similar to G.L. that I go to both Dr. Frank Walsh and Relationships Australia (R.A.). Perhaps R.A. put it the best. At our first meeting the counsellor, knowing Jan's history, told me what Jan was unable to confess to me in full. (i) Your marriage (*like your CBA account*) is over. (ii) Because your wife (CBA) does not love (*want*) you anymore. (iii) Because of the obvious, she had a new boyfriend (*CBA investment scammer*). (iv) Jan was unable to satisfy the sex life of two men (or several bank Manager's giving bad advice). (v) As a result, our children were witness to 4 yrs of endless arguments. Jan would say **"Do not touch me"**. When I asked why I was told **"If you don't know I shouldn't have to tell you."** This was to follow her Mother's lead. Jan asked me **"Why should I have to stay married to the same man all my life?"** Then **"Marriage was designed by men, women are not men's property."** Finally the truth **"I only married you because you had money."** With divorce, her demand **"Now I want all the cash."** (*With CBA planned liquidation this gave an expected \$4.4m profit to the creditors.*)
9. a/ Today's marriage is judged to be the toss of a coin, 50% good, 50% bad. What drove me crazy was Jan's statement to our children over and over **"Take no notice of your Father, I never did."** Both Aran and Belinda stayed loyal to their Mother's wishes. This was despite my efforts to promote an action plan. I learnt as a child in bible studies **"Give people fish and keep them poor, teach people how to fish and make them rich (in both body and the mind)."** But I was warned, the world may seem a strange place because money is the root of all evil:- **Never trust a money lender.** Just remember to keep the faith. So we have and we must follow the Senate lead for the CBA's CEO, Ian Narev's promise **"To put things right."** b/ Now consider the collateral damage, as Mark's wife, Ros, reminded me when she tried to tell me the obvious. Jan had a new lover who wanted to have honeymoon style sex in the afternoons and your marriage was over. As another Psych, Dr. Pamela Hudson-Jessop put it, **"Shit happens."** The problem is compounded, but there is always a solution. The need to find a new partner and a new bank. c/ Prior to my marriage with Jan, as my Mother was much older and wiser, she warned me not to marry Jan, but I thought we were both in love. My point being, when Jan divorced me my Mother said **"When Jan divorced you does that mean my Grandchildren have divorced me too?"** Mum's motive was because we never saw Belinda for 14yrs, from 16 to 30yrs of age. I continued to visit Walsh for the best part of 10yrs, but I was told **"I cannot solve your legal problems."** d/ As my original Solicitor put it when he set up our family companies and self managed superfund, **"I am happy to do your legal work, but if you ever divorce, as Jan is a 50% partner, it will be a nightmare, so do not come back to me."**

Yes, this is a major ATO / law reform nightmare, which I believe can only be resolved in producing a CALDB / ASIC LBB of Scams to cover the top ten ATO / superfund, bank and business scams, to educate the ATO, bank staff, Police, QDPP and bank customers. e/ For the best results, take note of Jan's input, quote **“For the sake of our children I want to leave our business intact.”** Jan came back at a later date and said **“Mum said I did not get enough and demanded another \$175,000.”** I was forced into a **'fire sale'** to go to my extended family and friends to borrow, on average \$32,000 from Mark, Terry, Tim, my Accountant, and for Mum to mortgage her home for \$110,000. Hence, my promise to include them in the profits from our superfund subdivision **'fire sale'**. But again G.L. stuffed up and said **“Rip up the contracts or I will close your CBA account, apart from a small housing loan.”** f/ Now you need to understand my Mother's shareholder home mortgage scam, which was a 14yr nightmare, in addition to Wilson's bokie extortion for \$47,692. Hence, Judge Shanahan's findings, that this is the best case for law reform and yes there is still more to come. This caused Davida, our fraudulent MOB Barrister to begin to fall apart. So Davida devised an exit plan, with the aid of the Justice Minister, Rod Welford and Grahame Ledwidge. Davida would plead guilty to the original 6 bank \$1.3m scams, with a plea-bargain. This plea-bargain was arranged, that despite receiving a 3yr jail term, initially she would receive a suspended sentence on the condition **she kept her mouth shut**. On the principle of negotiating a solution, we have numerous options. This is to do with QPS insider trading, normally handled at that time by the PESC / CMC and now due to their failure, the addition of Scamwatch. By law, the QPS should have acted on the Supreme Court mediation and discovery orders, but at no time did the QPS act on these orders. In fact, it was the reverse. Under witness we were loaded back into our car, driven out of town and warned by Noosa Police **“If you return you will be charged with being a public nuisance.”** (Our Noosa involvement was to attend an EPA seminar to expose Sect. 32 of the Act used to sabotage construction sites.)

10. a/ Hence, the importance to acknowledge Premier Newman's request for Editor of the Sunshine Coast Daily, Bill Hoffman's \$1.25b state loss each year in roting in the building and construction industry. b/ There is a simple solution. While most Police agree with the Premier's / Bill Hoffman's report that organised crime is real, Dr. Pathè's question must be answered. **How come we cannot get justice?** I will explain; opposite our local member, Minister Powell's office is the Maleny Police Station. Under the direction of ex-Police Comm. Bob Atkinson, supported by the now Commissioner, Ian Stewart, I was ordered to keep our local Police up to date with our progress. Thanks to Minister McArdle, I was directed by the Speaker, Fiona Simpson, to keep our local Minister Powell informed of our Environmental Heritage Protection progress. The QPS tried to laugh off the above Crown evidence that I was mentally insane and for the 4th time I have had to prove I am of sound mind. But this came with a warning from Prof. Pathè, that I provide a credible witness each time I made a visit. Most times I work with Lyn Nichols, my partner, (*whose Father and family were and are well-known Police*) to ensure the due process. **But instead, the local Sgt Riggs grabbed our latest official Police Crime Report and threw this Crown evidence into his waste paper basket and ordered me out of the station.** So I put it to you, if his parents and senior Police Officers were to fully test and investigate all our evidence, there is no doubt, due to C.C. 200, 205, 391, 399 and the QPS directed Judicial Review Act, that this case will be solved. c/ We can smash major extortion and racketeering scams, where I was attacked in my own home by bokie thugs, armed with a nun-chucker  and fraudulent extortion demand, but instead of receiving justice, 4 times we have been falsely charged to try and create the illusion that we are the criminals. The latest scam was that I am of unsound mind. d/ We live in a time of change, to explain, the Salvation Army, after a period of 20yrs, have apologised where the victim reported, from 4yrs of age as a ward of the state, she was raped by a Salvation Army Major, still alive and now 81yrs of age, but the QPS have so far failed to charge him. Police are quick to explain, the Fair Trading Act is treated as a joke. That is why we must stand up for our human rights. The people you trust the most do the most damage. Therefore, trust only the facts. We must stand as one for a **'Men's Shed'** solution to gain Supreme Court mediation and gain a list of the CBA, ABC reported 4,000 bank customers, who were trapped with fraudulent investment scams, **to act as one class action**. The QLS and QPS have ruled that my Mother's shareholder mortgage scam is the best case for law reform. This has proven to be new ground for Qld Members of Parliament and their staff who want to help, but need guidance to expose investment scammers. The Senate initiated inquiry, was confirmed by the CBA Case No Cf2087501,

with a **'no comment'** CBA alarm, after 14yrs of misery.
