I WAS TOLD BY PREMIER BEATTIE "TO FIND THE SOLUTION". PREMIER NEWMAN DID HIS BEST TO REFORM BIKIE RACKETS.

There is a need for revision, to understand how we got into this mess.

- 5. a/ From 1992 with the fear of death, the cancer created an extended family breakdown. In early 1995, I took my then wife, Janice's advice, to gain counselling from Clinical Psychologist, Dr. Frank Walsh. Walsh first said "To tell Janice it's okay to have both a family and family business". Janice did not have the courage to tell me the truth, but gave me a riddle "If you do not know, I should not have to tell you". Walsh gave me a clue and said "If Jan has a new boyfriend your marriage is over".
b/ I was brought up on traditional family values, once married you toughed it out, so your children got the best. Yes! I married for life. **PLEASE NOTE, IN RUNNING A FAMILY BUSINESS, WE ALSO HAD COMMITMENTS:-** (i) Staff. (ii) Superfund beneficiaries. (iii) To pay the ATO their estimated loss of \$460,311. This was due to the fact we had a well designed/multi-purpose self managed superfund, including a proposed 22 block subdivision.
- 6. Our original HEHS Solicitors explained "We are happy to set up your company/superfund structure". However, they gave us a warning, "If you ever divorce, do not come back". To mean, your divorce will be a nightmare; it was and still is. You must study the detail via Supreme Court ordered mediation, where the court registrars explained the need to study the Vexatious Litigants, Fair Trading and now CCC Acts. As key QPS Police Asst. Comm. 'whistleblowers' findings, the need now is to study the Judicial Review Act **COVERING THE 14 JUDGES ON THIS CASE.** *** We had a chain of Solicitors who made numerous changes and it's still a mess. We lived at the ATO retail office Adelaide St. Bne. for 10yrs, so please explain why we were told over and over "Mr Bright, if you do not leave this office now I will call the Police". We requested that the ATO Manager did call the Police **TO LAY RACKETEERING CRIMINAL CHARGES AS THE OBVIOUS SOLUTION.**

7. a/ Walsh's opinion "**As the Son of a WO1 in the RAAF you are trained to follow orders**". Walsh also said "**I cannot solve your legal problems. I can only say you are of sound mind and you have the ability within you to solve this case**". Hence, I took advice from the then Justice Minister Rod Welford and Police Minister Judy Spence, to volunteer this \$1m QPS requested budget. **WE MUST FIX THIS MESS FOR ALL VICTIMS.**
- b/ In brief, then Police Comm. Bob Atkinson said "**We must take note of Army Colonel/Judge Pat Shanahan's QLS law reform (ATO findings of an estimated \$460,311 loss)**". Shanahan also said to me "**Look at the obvious; you must prove abandonment is fraud**". We have since learnt from the 14 Judges, (7 Supreme Court) that the QPS Criminal Code sect. 399 is the Premier's requested solution, but it now must be written into law as the obvious **LAW OF ABANDONMENT.**
- c/ As Supreme Court admin Justice Byrne explained to me '**To complete the set on the three step Arbitration program**'. To mean, (i) the law of (*bikie*) Association. (ii) The law of (CBA) Accession. (iii) The law of (ATO) Abandonment. Thanks to the support of the Treasury Dept. Systems Management and Services Div. solution to enforce the ACCC/LBB of Scams, pg16, and the Public Curator's direction to stop abuse of the elderly (*cancer family victims*).
8. a/ Psychiatrist, Dr. Hudson-Jessop's opinion "**Shit happens**". Yes! I was blamed and treated as the fool, along with the CBA Loans Manager James Pitman, but you must agree that by law the superfund beneficiaries must not suffer as a result of this CBA confessed "**Bank circus**".
- b/ The CBA Loans Officer agreed, that the eight beneficiaries who lost on average \$125,000 each must be compensated. This includes my Mother, who spent the last 15yrs of her life, aged 80 to 95, **LIVING WITH THE THREAT** if she did not pay Rob Wilson's ACCC fake invoice then Mum would lose her home due to the '**Shareholder Home Mortgage Loan Scam**'. Under legal advice from de Groot's Lawyers, with my son Aran's help, Mum signed a family trust to prevent Wilson using his scam to steal my Mother's home.
9. Mum's Doctor, as detailed above, also wrote to the ATO on our superfund behalf, but to this date has not received a reply from the ATO. Why ignore our request for help to file our superfund in a way to expose well organised crime? The ATO Act, to blame and fine the victims for late lodgement, when for the past 10yrs we could not find an Accountant prepared to support our original Accountant Tim Allen's '**damages report**', designed with the intent for the QPS to lay racketeering charges.
10. Therefore, Dr./Prof. Pathè has given her support, to reopen this QPS case in support of the Treasury Systems Management law reform, via CEO Meg Quinn's assistance. On the obvious conditions that when the ATO books balance to standard testing procedures, we will have achieved CIB requested '**NATURAL JUSTICE**'. As Colonel/Judge Shanahan put it "**The court transcripts and the money trail will solve this case**". After 15yrs of ATO abandonment
